Update from Brookline Town Meeting

On Tuesday, May 23, Town Meeting made significant and successful votes in support of the renovation and expansion of Brookline High School, the 9th Elementary School at Baldwin, and the FY 2018 school budget.

Town Meeting voted strongly in favor of moving forward the Brookline High School Renovation and Expansion project into the Schematic Design Phase. The 216 to 1 vote to allocate \$1.85 million allows the BHS Building Committee and architects to further develop Preferred Design "Option 4D". This design will maintain one, unified campus for BHS by adding a 9th grade building on Cypress Street, creating a new Science and STEM center on the corner of Tappan and Greenough Streets, and renovate existing classroom and common spaces in the main building. The additions will help create a small school feel for 9th graders as they transition from our elementary schools, while allowing them to access arts, athletic, and upper-level courses across campus. Upgrades at the main building will allow for state of the art science facilities, enable integration across disciplines and include collaborative spaces for all grades. BHS Building Committee Chairs Selectman Nancy Heller and School Committee Member Susan Wolf Ditkoff presented a strong case for moving forward and the current timeline for the project.

Town Meeting voted 185 to 32 in support of a motion to appropriate \$1.5 million to continue work on developing the design for the 9th Elementary School at Baldwin. Chairman of the Board of Selectmen Neil Wishinsky and School Committee Chair David Pollak made spoke in favor of moving the project forward. While this is a positive step, these funds cannot be expended and the Schematic Design Phase cannot begin until the Board of Selectmen, the School Committee, and the town's Advisory Committee receive additional legal guidance related to open space regulations and the Smith v. Westfield court case that is pending before the state's Supreme Judicial Court and another Town Meeting vote releases the funds. The vote does allow \$100,000 to be spent to complete the feasibility study and do further design work.

In a nearly unanimous vote, Town Meeting approved the town's budget including \$104 million for the FY 2018 public schools budget. Next year's budget allows us to maintain and build on the increased staffing that we have experienced across all schools over the past two years and continue the work begun this year to align programs, policies, and systems to better support students and teachers. The budget supports our core values of educational equity, high achievement for all, excellence in teaching, respect for human differences and collaboration while continuing to address our ongoing enrollment growth. The FY 2018 budget reflects a \$4,144,746 increase and includes a \$4,837,000 increase in personnel expenditures, a \$308,000 increase in services and cuts in supplies of \$172,843. As is the case every year, this budget is the culmination of significant work done by coordinators, principals, BHS department chairs and deans, and particularly Beth McDonald, Michael D'Onofrio, and Mary Ellen Dunn. Thank you to all who contributed to creating a clear and comprehensive budget that earned significant support from the Advisory Board and Town Meeting.

Driscoll School Principal Transition

As you know, on May 22 Driscoll School principal Heidi Cook announced that she has taken a new position with the Cambridge Public Schools. We wish Heidi all the best. I communicated with the Driscoll community on May 22 and followed up with the letter below on May 31 informing them that I will be appointing an interim principal for the 2017-2018 school year.

May 31, 2017

Dear Driscoll School Staff and Families,

I write today to let you know that I am currently working to identify an interim principal to lead the Driscoll School in the coming school year. Given the announcement of Principal Cook's plans at this late date in the year, there is insufficient time to permit a complete search that would attract a deep and diverse pool of candidates. Consistent with School Committee policy on filling interim positions, I am currently considering high quality candidates both within and outside of the system and will make an appointment within the next week.

In November of the coming school year, we will launch a comprehensive search process to identify a permanent leader for Driscoll School. This process will include a representative search committee that will select and interview candidates, a second round of interviews, in-depth reference checks, site visits, and candidate forums for finalists to be held at Driscoll.

Thank you for your patience while my team and I work to find an appropriate and talented leader who will support the entire Driscoll community through this transition.
