PRESCHOOL AND PRE-K CLASSES AND LOCATIONS

BEEP will offer **Preschool** classes for **children ages 2.9 - 3.2** in the following four locations.

BEEP will offer **Pre-K** classes for **children ages 3.0- 4.11** at the following seven locations for the coming school year.

*Please note: If your child is turning 3 years of age in June, July or August, we recommend that you consider applying for **preschool**.

SCHEDULE

The BEEP schedule for the 2025-2026 school year is **Monday - Thursday, 8:00am - 2:30pm** and **Friday, 8:00am- 1:40pm**.

TUITION

BEEP is a tuition based program. The annual tuition for BEEP for the 2024-2025 school year is \$15,500. The annual tuition for BEEP Extended Day is \$7,000. Tuition rates are subject to change each school year. The 2025-2026 school year tuition rates will be determined and voted on by the Brookline School Committee in the spring. BEEP offers annual, bi-annual and monthly payment plans.

FINANCIAL ASSISTANCE

Financial assistance for BEEP is limited. The Public Schools of Brookline offers financial assistance to a total of 40 eligible families each school year. Please [click here](#) to view eligibility requirements.

Financial Assistance Applications for SY 2025-2026 applicants to BEEP are due by **January 15, 2025**. A new financial assistance application is required every school year.

EXTENDED DAY OFFERINGS FOR SEPTEMBER 2025- JUNE 2026

Extended day programs will be managed and run by private non-profit organizations at the Beacon, Driscoll and Hayes locations. At Lynch and Putterham, extended day will be managed by BEEP. Receiving a placement in BEEP does not guarantee admission in an extended day program. Space in the extended day programs is limited.

LYNCH CENTER- 599 BROOKLINE AVENUE

Extended day for BEEP students enrolled at Lynch Center, 599 Brookline Avenue will be managed and run by BEEP. We will offer an extended day program onsite until 5:30pm. If your child is accepted to BEEP at Lynch on **March 1**, you will receive an email that includes an application for extended day and instructions on how to apply. PUTTERHAM- 194 GROVE STREET

Extended day for BEEP students enrolled at Putterham, 194 Grove Street will be managed and run by BEEP. We will offer an extended day program onsite until 5:30pm. If your child is accepted to BEEP at Putterham on **March 1**, you will receive an email that includes an application for extended day and instructions on how to apply.
