5:50-6	Pierce MSBA Renovation Project Update	Still in the preliminary design phase. The architects, owner's project manager, and the project manager meet

		<p>2x a month. Different plans were created and have been revised. We have 4 final proposals.</p> <p>Between now and thanksgiving, the building committee will vote on 1 “prefered schematic” and that will be sent to MSBA.</p> <p>Staff got a presentation on 9/24. There will be a community meeting on 10/25 from 7-9.</p> <p>Plan 1. Preserves all of Unit A and C, tears down the rest and connects to the HB. Most difficult of the proposals for educational scheduling as grade levels won’t be with each other for adjacency issues.</p> <p>Plan 2: Keeps Unit A, tears down the rest, connects to the HB. Slightly better job than 1, but still has adjacency issues.</p> <p>Plan 3: All of the 1970s building are torn down. Abandons the HB, which means the town will have to pay for reno. Builds most compact school, but also the tallest (4 stories; the others are 3). Best adjacencies, reduces transition time. Core spaces are at the core.</p> <p>Plan 4: All of the 1970s buildings are torn down. Builds all new but connects to HB. Isolates Pre-K (1st floor of HB) and 8th (on the assumption that they’re the fastest transitioners)</p> <p>The prices are similar in nature. There are concerns that options 1 and 2 may be more expensive due to unforeseen costs. Also, Pierce is above the parking for town hall and library.</p>
