LeftField has reviewed the Designer Contract Amendment No. 6 presented by Jonathan Levi Architects for reimbursable services provided by their Fire Protection Consultant, Garcia, Galuska & DeSousa (GGD). ## **CONTRACT FOR DESIGNER SERVICES**

#### AMENDMENT NO. 6

WHEREAS, the TOWN OF BROOKLINE ("Owner") and JONATHAN LEVI ARCHITECTS LLC. (the "Designer") (collectively, the "Parties") entered into a Contract on August 31, 2018, ("Contract") for Designer Services for the <u>New Construction of the Michael Driscoll Elementary School,</u> <u>Abatement and Demolition of the Existing School, Site Improvements and All Associated Work</u> at the 64 Westbourne Terrace, Brookline, MA 02446; and

WHEREAS, the scope of this work is summarized in the attached Proposal for basic Geo-Environment Engineering Services and Geotechnical Services including Supplemental Subsurface Exploratory Services for Geo-Environmental and Geotechnical Services from McPhail Associates, Inc.; and

WHEREAS, Contract Amendment No. 2 was approved by the Town of Brookline on January 17, 2020; and

WHEREAS, Contract Amendment No. 3 was approved by the Town of Brookline on March 18, 2020; and

WHEREAS, Contract Amendment No. 4 was approved by the Town of Brookline on March 26, 2020; and

WHEREAS, Contract Amendment No. 5 was approved by the Town of Brookline on March 26, 2020; and

WHEREAS, effective as of May 12, 2020, the parties wish to amend the contract, as amended:

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained in this Amendment, and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

- The Owner hereby authorizes this Contract Amendment No. 6 for the total value of <u>\$1,375.00</u>. This Amendment is based on JLA's Consultant Garcia, Galuska & DeSousa's Proposal, dated April 23, 2020 for \$1,250.00 and JLA's administrative mark-up of 10%. The Designer is herein authorized to commence the services outlined in this Amendment, pursuant to the terms and conditions set forth in the Contract, as amended.
- 2. For the performance of services required under the Contract, as amended, the Designer shall be compensated by the Owner in accordance with the following Fee for Basic Services:
