Last Wednesday, October 24, 2024, the Capital Subcommittee met to review the administration's recommended FY26 Capital Improvement Plan (CIP). The plan was developed with extensive input from principals, Charlie Simmons, the Director of Public Buildings, Joe Albuquerque, Director of Operations, and the Capital Subcommittee. The Capital Subcommittee approved the CIP as presented with a few suggested modifications to the format. The documents presented for School Committee approval have incorporated the feedback provided by the Subcommittee last week.

Given the way the CIP deferred maintenance funding was approved at Town Meeting last spring, this year's capital plan is presented in two parts; modifications to last year's FY25 & FY26 Deferred Maintenance plan and new, currently unfunded, CIP requests. Town Meeting approved \$2,983,675 for FY25 & FY26 Deferred Maintenance with the following stipulation.

"Any School Department-approved deviations to the amounts shall be subject to the approval of the Select Board at a duly noticed Select Board meeting and with prior notification to the Advisory Committee."

For this reason, the Deferred Maintenance plan provides an accounting of the work completed in FY25, current estimates for deferred maintenance, and the project plan for FY26. This allows the viewer to see what work is scheduled to be performed in FY26 with the funds remaining from the Town meeting allocation of \$2,983,675. The vote for these modifications follows.

Motion 1: To approve the modifications made to the FY25/FY26 deferred maintenance project allocations as presented in the FY26 Capital Improvement Plan and submit this request to the Select Board at a duly noticed Select Board meeting for approval.

Motion 2: To approve the FY26 School Capital Improvement Plan in the amount of \$1,236,948 to fund the requests for Classroom Capacity leases (\$761,948), Furniture Fixture and Equipment (\$75,000), and Long Term Capital Plan (\$400,000).
