Here is a brief description of the PTO College Essay workshop we hold each fall at BHS.

Since 2003, the Brookline High School PTO has partnered with members of the high school English department to advertise, plan, and offer a free college essay workshop to members of the senior class. Two workshop coordinators collaborate with PTO leaders to solicit the partnership of parent and community volunteers alongside paid faculty members, usually from the English department, who lead sessions with students.

Seniors are organized into groups based on where they are in their college essay process and then spend a Saturday morning in late September or early October receiving instruction and feedback on their essays. Each year, the event galvanizes the senior class and gives participants the opportunity to make progress on a critical component of their college applications at no charge.

Dear Mr. Pearlman:

I am pleased to enclose a check in the amount of \$30,592.74 as a distribution from the John Emery Hoar Foundation, a charitable trust created under the will of the late D. Blakely Hoar. Under the terms of Section 16 of Mr. Hoar's will, the enclosed sum is to be used "for the benefit of Brookline High School".

As you may be aware, the primary charitable purpose of the Trust is to hold nonagricultural and wooded land for cultivating forests, producing lumber and establishing bird preserves. The trustees, in accordance with a professionally developed forest management plan, have been conducting timbering operations on the Trust's property in New Hampshire. Last year, those timbering operations resulted in a profit, a portion of which has been added to this year's distribution. Although the trustees are pleased to have been able to include the timbering profits in this year's distribution, whether there will be any such profits next year or in the years to come will depend on several factors which cannot be determined at this time.
