I recommend the School Committee vote to accept the gift of 4 park benches, 4 picnic tables, and 1 two-row, 24' bleacher being donated by Chestnut Hill Realty at the upcoming March 16 meeting. The value is estimated at \$10,387.76; a quote is attached for your reference.

This is a turnkey gift, and the equipment type and models, placement locations were selected in accord with input from the Baker PTO, Principal Lewis, DPW staff, myself, and Chestnut Hill Realty staff Andrew Martineau. The materials are expected to be low maintenance for DPW and improve the playground experience for Baker students and the community. All involved support accepting this gift.
