

# FY2023: Strengthening Career and Technical Education for the 21st Century Act (Perkins V) Secondary Allocation Grant

#### Purpose:

The mission of the Massachusetts Department of Elementary and Secondary Education (DESE) is to strengthen the Commonwealth's public education system so that every student is prepared to succeed in postsecondary education, compete in the global economy, and understand the rights and responsibilities of American citizens, and in so doing, to close all proficiency gaps.

The goal of Massachusetts' public K–12 education system is to prepare all students for success after high school. Our five core strategies to accelerate the pace of school improvement are:

- Strengthening standards, curriculum, instruction, and assessment
- Promoting educator development
- · Supporting social-emotional learning, health, and safety
- Turning around the state's lowest performing districts and schools Enhancing resource allocation and data use

#### Massachusetts Acceleration Roadmap

Additionally, Massachusetts has developed a tool to support acceleration of student learning. Schools and districts are encouraged to use the self-assessment resources in the Roadmap to identify key areas of focus and related action steps in their work accelerating learning, and then align their funding requests with these identified steps.

Applicants for this grant opportunity should be deliberate and intentional in the use of grant funds to support DESE's standards and priorities.

The purpose of this federal grant is to assist school districts in improving secondary-level programs that meet the definition of career and technical education as contained in the Strengthening Career and Technical Education for the 21st Century Act P.L. 115-224 (Perkins V)

#### **Priorities:**

The priority is to close the achievement gap on the <u>Perkins core indicators of performance</u> for populations who are chronically unemployed or underemployed, including special populations.

#### **Eligibility:**

A district or collaborative is eligible to receive funds based on criteria established by the United States Department of Education (USED). Districts must offer Career Technical Education programs that comply with the various elements of Perkins V. In addition, districts must develop a Comprehensive Local Needs Assessment. Grants are awarded to local school districts after the state reviews and approves a district's grant application.
