Mr. Murphy was Chief Executive Officer of Bay State Federal Savings Bank 1299 Beacon Street, Brookline, MA. He joined Bay State Federal Bank, Inc. in 1961 and served in various positions until 1976 when he was named President and Chief Executive Officer of the bank. In 1994 he was also named Treasurer of the bank. In 1996, Mr. Murphy was elected Chairman of the Board of Directors. He had been a member of the Board of Directors since 1975. Mr. Murphy was a Director of Connecticut On-Line Computer Center Trust and was a member of the Legislative, Secondary Market and Federal Home Loan Bank System Committees and the Government Affairs Council of the America's Community Bank. He was a past President of the New England League of Savings Institutions and a former Director of the Federal Home Loan Bank of Boston. Mr. Murphy received a Bachelor of Science from Northeastern University.

At the Town Members Meeting in 1999, on behalf of the Bay State Federal Savings Charitable Foundation, Mr. Murphy committed \$500,000 for funding furniture, fixture and equipment for Brookline Senior. This was one of the first, the largest and most formidable contribution in the history of our Foundation.

7. Please explain history of Scholarship. Why is it being established?

As a Brookline based bank, Bay State Federal Savings had a vested interest in the community not only to the Senior Center but also, Brookline High School offering support to the C-21 Program and Student Scholarships. The bank used to hold a cookout in our parking lot for the students who volunteered and participated in the SHOP program. Our Charitable Foundation continues to offer an annual scholarship to honor Agnes Rogers for her dedication to the Brookline Seniors and the Brookline Senior Center. Mr. Murphy had a great affection for the Seniors in Brookline and felt it important to always bridge the generational gap in an effort to ensure the mutual respect and exchange of thoughts and wisdom.
