The Brookline School Committee ("Committee") and the Brookline Educators Union – Unit A ("Union"), collectively referred to as the "Parties", agree to modify their 2016 – 2019 collective bargaining agreement ("CBA") with the following modifications:

- 1. Effective September 1, 2018 amend Appendix B.8 by increasing Coaching Stipends by 2% (See Attachment A).
- 2. Coaching Stipends shall be added and/or reclassified as follows:
