RE: Recommendation to approve CTA Change Order 010

Dear Mr. Masak:

CTA Construction Managers is submitting original copies of Change Order 010 for the Brookline High School Tappan Gym and 3<sup>rd</sup> Floor Renovation for acceptance by the Town of Brookline (ToB). Hill and WRA have previously reviewed, negotiated where applicable, and agree that all items listed in this Change Order are fair, reasonable for the described scope of work, and are compensable adjustments to the Lump Sum Contract. This change order is an additional cost total of \$61,076.63.

CTA has been solving the issues with the design team and ToB to minimize added time and complete the job. For these reasons we recommend acceptance of this change order.

The PCOs are categorized as follows:

- (4) PCOs are a Design Omission change.
- (3) PCOs are the result of miscellaneous changes.
- (3) PCOs are results from unforeseen conditions discovered during construction.
