## Request for Revolving Fund March 28, 2018

The School Department requires specific authorization for new revolving funds.

School Committee Action Requested: The School Department would like to request that the School Committee authorize the Town Accountant to set up a Revolving Fund, with an organization code for each building, for the following:

- Lost Books Revolving Fund
  - O MGL Ch. 44 Sec. 53 authorizes School Committee to create a revolving fund for the collection of fees for lost books and computers. Currently, the fees are held in a student activities account at the high school and is disparate places for the K-8 schools. This fund will allow for uniform fee collection and a simplified process for accessing those funds to replace the lost books and computers.
  - o Current BHS Student Activity Account Lost Book Subaccount Balance:
    - Library \$4,475

Motion: Approve account creation for "Lost Books Revolving Fund" per the attached documentation and authorize the transfer of the above amount from the BHS Student Activity Lost Book Subaccount into the revolving fund.
