Schedule Commentary

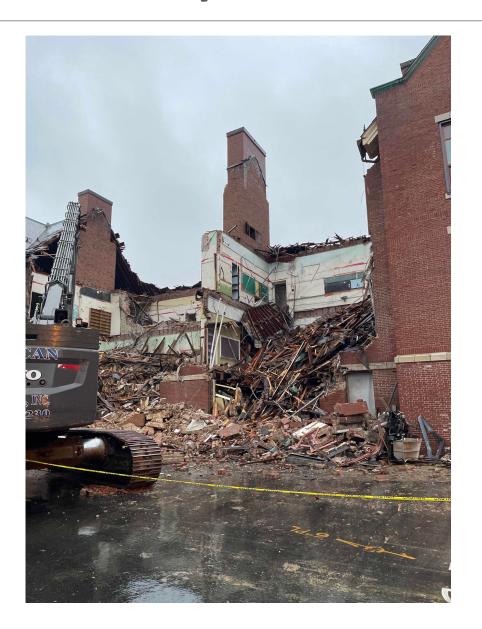


Phase 2
